i, _____, an aggrieved wo/man, hereinafter “Declarant,” am of legal age and one of the American people and having standing as such under the Articles of Confederation, The Declaration of Independence, and having unalienable God-given rights guaranteed the people as defined in the XIII Articles of the Bill of Rights Amendment to the Constitution for the United States, and having a God-given unalienable right to “clean water,” have firsthand knowledge of the facts contained herein, am competent to state the following matters, that they are true, correct and complete, presented in good faith and not intended to mislead.

“i, _____, am an aggrieved wo/man, being over the age of 18 and competent to testify, having firsthand knowledge of the facts herein, on my unlimited commercial liability and the laws of the original jurisdiction of the state of upper/lower State name that i have read the above declaration and do know that the facts contained herein are true, correct and complete, not misleading, the truth, the whole truth and nothing but the truth, to the best of my knowledge and belief in regard to members of the American Bar Association, to include all members of all State Bar Associations that are foreign-agents having allegiance to a power foreign to America and having no American citizenship, that they are effecting by force a treasonable object adverse to the interests and rights of the American people, respectively the Declarant herein defined, and citizens of the United States, that said foreign agents are incompetent and lack absolute standing in any lawful court to bring any claim or judgment against or upon the herein defined American national of the executive and judicial branch of American government, under an (“ALL-CAPITAL

_____, hereinafter “ENVIRONMENTAL TERRORISTS,” have committed acts of trespass on the Rights of Declarant;

1.) i see no evidence to rebut the fact that Declarant is an aggrieved wo/man and is suffering harm and personal injury directly resulting from trespasses upon rights guaranteed me as one of the American people, said overt acts of trespass being done in the nature of domestic and international “environmental” terrorism by intimidation and coercion in knowing violation of Pub. L. No. 107-56, 115 Stat. 272, enacted October 26, 2001; overt acts of trespass to affect the conduct of a government causing harm and mass destruction, assassination and kidnapping in knowing violation of Pub. L. No. 92-500, 86 State. 816, enacted October 18, 1972; and all above defined are acting in collusion with the other, aiding and abetting the other to commit these terroristic overt acts of trespass upon Declarant in violation of Pub. L. 91-452, 84 Stat. 922, enacted October 15, 1970, by the above defined TERRORIST(s), “FEDERALISTS” foreign to the American people, knowingly acting with intent to harm by acting in gross violations of the Clean Water Act of 1972, and i deny that such evidence to make controversy against the stated exists;

2.) i see no evidence to rebut the fact that Declarant is an American national and shall not be construed as a “citizen of the United States” in the meaning of the 14th amendment to the corporate charter of the private corporation, aka UNITED STATES OF AMERICA, Inc., impersonating a legitimate government at federal, state, county and municipal levels, DOMESTIC and INTERNATIONAL TERRORISTS, and that by executing a voter’s registration I would have been or was defrauded and such act could NOT cause me, as an American national, to lose my sovereignty as an American national of superior status and standing in the executive and judicial branches of government pursuant to my rights retained as defined in Article IX of the Bill of Rights Amendment, and i deny that such evidence to make controversy against the stated exists;

3.) i see no evidence to rebut the fact that Declarant is aware said ENVIRONMENTAL TERRORIST(s) is an employee of a private corporation having a Dun & Bradstreet Number and is impersonating a “public official,” more specifically, judges, peace officers and constitutional counsels, having absolute NO enforcement authority over Declarant who is NOT an employee of any of their private corporations, nor knowingly having had full disclosure or entered into a contract which would subject me to same, and i deny that such evidence to make controversy against the stated exists;

4.) i see no evidence to rebut the fact the Declarant is NOT an employee of the private corporation known as STATE OF (ALL-CAPS STATE OF NAME) _____ or ‘subject’ citizen of the UNITED STATES, INC., and accordingly is NOT subject to said corporations’ private codes, rules, regulations or ordinances [*cf.* Rodrigues vs. Ray Donovan 769 F2d 1344, 1348 (1985)]; and further, that the Rules of Evidence for all courts of the United States and magistrates, the Amendments to the Federal Rules of Civil Procedure, and the Amendments to the Federal Rules of Criminal Procedure, which are embraced by the orders entered by the Supreme Court of the United States on Monday, November 20, 1972, and Monday, December 18, 1972, shall have no force or effect, except to the extent, and with such amendments, as they may be expressly approved by Act of Congress, Pub. L. 93-12, 87 Stat. 9, enacted March 30, 1973, which has never happened, and i deny that such evidence to make controversy against the stated exists;

5.) i see no evidence to rebut the fact the Declarant has NOT caused harm, loss or injury to any man or woman and NO VERIFIED CLAIM/COMPLAINT has been executed, under oath and penalty of perjury, by any harmed man or woman against the Declarant [*cf.* Allen v. Wright, 468 U.S. 737, 751 (1984)] and i deny that such evidence to make controversy against the stated exists;

6.) i see no evidence to rebut the fact that there is no lawful court of competent jurisdiction in the above defined State that has a MOVING INSTRUMENT to justify GOOD CAUSE; and accordingly, lacks both personal and subject matter jurisdiction in any case that has been brought against Affiant/Declarant thereby justifying a counter-claim to be brought against the above defined environmental terrorist(s) who have trespassed upon my God-given unalienable rights as defined in the Bill of Rights Amendment to the US Constitution having only Thirteen Articles; and ratified by Virginia State republic on December 9th, 1812, and i deny that such evidence to make controversy against the stated exists;

7.) i see no evidence to rebut the fact that the overt acts committed by this VIOLATOR trespassed upon the following rights guaranteed me under said Bill of Rights which are:

Overt Act # One

Right violated: Bill of Rights, Article I

Offense: Trespass upon right to peaceably assemble

Overt Act # Two

Right violated: Bill of Rights, Article III

Offense: Trespass into a house of the people, absent consent, absent lawful cause

Overt Act # Three

Right violated: Bill of Rights, Article IV

Offense: Trespass depriving the people of the right to be secure in their persons, houses, papers, and effects, including automobiles

Explain: Poisoning a person via their domestic drinking water is a criminal violation of this right and an act of war.

Overt Act # Four

Right violated: Bill of Rights, Article V

Offense: Trespass by depriving a person of life, liberty, or property, without due process of law

Explain: Poisoning the public's drinking water supply is a criminal violation of this right and an act of war.

Overt Act # Five

Right violated: Bill of Rights, Article V

Offense: Trespass of taking private property from a person for public use, without just compensation

Explain: Forcing the people to waste water, depriving them their right to reclaim and reuse it is a criminal negligence violation of this right.

Overt Act # Six

Right violated: Bill of Rights, Article VIII

Offense: Trespass by imposing cruel and unusual punishment to be inflicted, i.e. false arrests and imprisonments

Explain: Poisoning the people of a district's water and food is a criminal negligence violation of this right.

Overt Act # Seven

Right violated: Bill of Rights, Article IX

Offense: Trespass by denying rights retained by the people

Explain: Denying the right of the people to clean water is a criminal negligence violation of this right.

Overt Act # Eight

Right violated: Bill of Rights, Article IX

Offense: Trespass upon the people, i.e. states, the kings, the masters, having foreign state sovereign immunity from trespass by the United States or its subject citizens and foreign agents

Explain: The people have immunity from domestic environmental terrorism being committed against them by inferior citizens of the United States or their subject foreign federal agents.
